



## Traverse Therapeutics Reports Inducement Grants Under Nasdaq Listing Rule 5635(c)(4)

SAN DIEGO, Jan. 12, 2022 (GLOBE NEWSWIRE) -- Traverse Therapeutics, Inc. (NASDAQ: TVTX) today announced that on January 10, 2022, the Compensation Committee of its Board of Directors granted inducement equity grants covering an aggregate of 42,000 shares of its common stock to five new employees, consisting of inducement stock options to purchase an aggregate of 33,000 shares of common stock and inducement restricted stock units, or RSUs, covering an aggregate of 9,000 shares of its common stock. These inducement stock options and inducement RSUs are subject to the terms of Traverse's 2018 Equity Incentive Plan ("2018 Plan"), but were granted outside of the 2018 Plan and were granted as inducements material to the new employees entering into employment with Traverse in accordance with Nasdaq Listing Rule 5635(c)(4).

The stock options have an exercise price of \$28.04 per share, the closing price of Traverse's common stock on the date of grant, are non-qualified stock options, have a 10-year term and vest over four years, with 25% of the shares vesting on the one-year anniversary of the grant date and the remaining 75% of the shares vesting in equal monthly installments over the following 36 months, subject to the new employee's continued service relationship with Traverse through the applicable vesting dates.

The RSUs vest over four years, with 25% of the shares vesting on each anniversary of the grant date, subject to the new employee's continued service relationship with Traverse through the applicable vesting dates.
