- On January 31, 2020, the reporting person was granted performance restricted stock units (RSUs) covering 15,000 shares of the Issuer's common stock. On August 31, 2023, RSUs vested upon the closing of the sale of the Company's bile acid portfolio following a modification approved by the Compensation Committee for a reduced number of shares to vest under RSUs originally granted on January 31, 2020 that were to vest upon specified clinical or regulatory milestones related to the Company's bile acid portfolio.
