QVT Financial LP ("QVT Financial") is the investment manager for QVT Fund V LP and other private investment funds (collectively, the "Funds"). The Funds aggregately own 1,675,212 shares of Common Stock. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 1,675,212 shares of Common Stock, consisting of the shares owned by the Funds.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Funds, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Funds, and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 1,675,212 shares of Common Stock.

An entity affiliated with QVT Financial (the "Additional Holder") beneficially owns 144,446 shares of Common Stock. Each of QVT Financial, QVT Financial GP LLC, QVT Associates GP LLC and the Funds disclaims beneficial ownership of the shares owned by the Additional Holder.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated on the basis of (i) the sum of (a) 12,095,143 shares of Common Stock outstanding, which was the total number of shares issued and outstanding reported in the Issuer's Quarterly Report on Form 10-Q for the quarter ended March 31, 2013, filed with the Securities and Exchange Commission on July 24, 2013 and (b) 5,555,556 shares of Common Stock issued in the Issuer's private placement financing, as reported in the Issuer's Form 8-K on August 20, 2013 and (ii) 564,100 shares of Common Stock underlying warrants, pursuant to Rule 13d-3(d)(1)(i).
